The move, aimed at ending congestion at toll plazas besides ensuring leakage-proof toll revenue collection, was introduced in September 2017. FASTags are affixed on the windshields of vehicles and use radio-frequency identification technology to enable vehicles to pass through toll plazas, through designated lanes, without waiting in queues as the payment is made electronically.

"Technology has helped in tracking truck movement. Together these initiatives ensured the road sector remained alive," said Vishwas Udgirkar, partner, Deloitte Touche Tohmatsu India LLP.

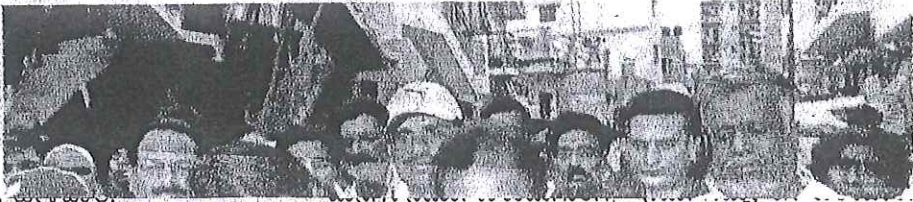

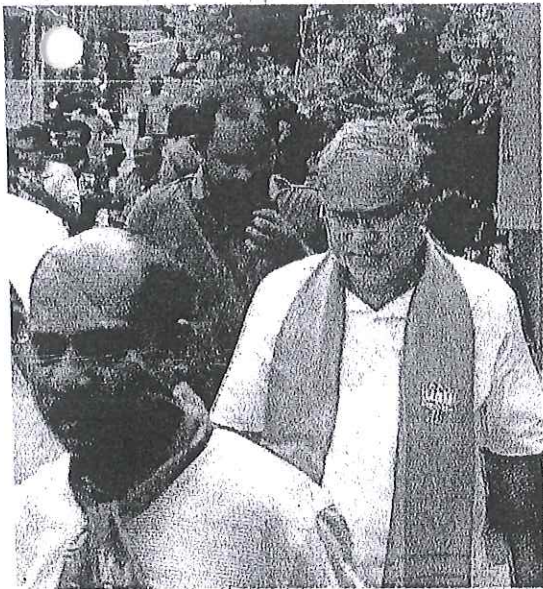
